THUR -FRI-SAT THE WALKS WILL BE SPLIT IN HALF AND IT WILL BE WALK/WALK RUN WITHIN THOSE GROUPS

LOOK ON THE GATE SHEETS TO SEE WHERE THE SPLITS WILL HAPPEN

ALL OTHER CLASSES WILL WALK ALL HEIGHTS TOGETHER

EXC STD JWW AND STD WILL ALLOW CONFLICTS TO RUN BEFORE THE START OF THE FIRST HEIGHT YOU MUST MARK YOURSELF ON THE SHEETS IN THE CONFLICT AREA PROVIDED BEFORE THE WALKTHRU

If you do not mark conflicts on the gate board with a "C" you will be marked absent at the end of your height. Gate sheets for all classes will be available for check in starting at 7 am. They will be located adjacent to the Trial Secretary table.



BREED /OBEDIENCE CONFLICTS??

It is the exhibitor's responsibility to be at the ring with their dog when it is their turn to run. To the extent it is possible we will attempt to resolve your run conflicts. Those of you with breed or obedience conflicts at the start of the day may move first in the run order for the first class if that helps. We will offer a conflict group that will run all heights prior to the start of the class in Exc STD and Exc JWW. They will walk with the dogs that run first. Conflicts will run before the 1st regular scheduled height. Please do not abuse this privilege. If asked, you must provide proof that you have a conflict in breed or obedience.

If you have a conflict that needs resolved otherwise, please mark a "C" by your name and get back as soon as possible. If there is not a "C" marked, then your scribe sheet will be marked ABSENT at the end of the height. You may always walk in an earlier group then get back to run in your height. Please do not ask us to hold heights all day. Once a class is done there will be no holding of any ring. Exhibitors are NOT ALLOWED to move dogs on the gate board once they are posted - you must ask a gate steward to do it for you, Exhibitors running multiple dogs with less than 10 dogs between them may ask the gate to *move one dog*. We will make every effort possible to get your conflicts resolved so you don't lose your run. ☺

MOVEUPS

Dogs may be moved up to a higher level class at the request of the owner as a result of qualifying for an agility title provided that request is made in writing to the trial secretary (Email is preferred before the trial).

Move-ups for Thursday must be received no later than 6 PM, Monday, Dec. 4, 2017

Day to day move-ups will be accepted for these trials but must be submitted in writing to the trial secretary no later than 30 minutes after the last run is judged in that class (STD, JWW, or FAST)

There will be a move-up book at the ribbon table. Please fill out the form and leave it in the book.

Arm Bands

You no longer need an armband.

Dogs To Be Measured

There WILL be an official measurer. If you indicated on your entry that your dog needs measured then you must be measured before you run. We do not need to see a card from any exhibitor that did not check the "My Dog Needs Measured" box on the entry blank. It is YOUR responsibility to make sure your dog gets measured if needed. Please check with the Trial Secretary table if you do need measured.

Do not risk a Q - Get measured before running!

Measuring will be available each morning starting at 7:00 near the score table





WORKERS

The worker schedule will be posted on my website and also emailed to all exhibitors when available. Workers will get raffle tickets for some great prizes and also get to eat from our wonderful worker spread. ☺ During the trials, Thelma may be found at the worker check in table in between the rings. Please check in with her to let her know you are there in the morning and to get your lunch and raffle tickets. There will be a large master worker list hanging at this table where you can mark yourself in, and also smaller ones available if you need a copy. If you see a potential conflict just let Thelma know so she can replace you. We want everyone to have plenty of time to have their dog ready and warmed up for your own runs!

DIRECTIONS TO SHOW SITE

From South – North on I-71 to Snow Rd- Airport exit. Left on Snow Rd to dead-end at Rt. 237. Left on Rt. 237 to I-X Center exit. Turn right and use 1st entrance to the I-X Center

From North – I-480 to Airport Exit. South on Rt. 237 to I-X Center exit. Turn right and use 1st entrance to the I-X Center

From West – I-480 to I-71(Columbus). South on I-71 to Snow Rd- Airport exit. Right on Snow Rd to dead-end at Rt. 237. Left on Rt. 237 to I-X Center Airport Exit. South on Rt. 237 to I-X Center exit. Turn right and use 1st entrance to the I-X Center

The IX opens at 6 am each morning
