Building will open at **7 am** both days.

This is a one-ring trial and we are only allowed to crate on the side we are using. Absolutely NO dogs allowed in the arena we are not using. Please respect all “no crating” signs.

Thank you for entering our agility trials. Please check your confirmation letter carefully to see if there are any errors. If there are any problems or corrections, e-mail me at CSTrialEntries@aol.com. Friday move-ups MUST be in my hands in writing **by Monday, October 2nd at 6pm** (per AKC rules). Day-to-day move-ups will be accepted on Monday up until ½ hour past the last run.

There is a food concession available on the site.

Judge Amanda Moller is a VMO. Please check in with the REGISTRATION table if you need to be measured. You may arrive any time prior to your class if not needing measurements. YOU NO LONGER NEED TO SHOW US YOUR HEIGHT CARDS ☺ BUT IT IS YOUR RESPONSIBILITY TO GET YOUR DOG MEASURED IF NEEDED.

In the past we have had problems in the crating area with over-reactive dogs. We understand the aisles are close, but please be careful where you place your crates so that we do not have dogs lunging at passing dogs. There are plenty of out-of-the-way spaces to give your dog privacy. We appreciate your cooperation in the crating area. If there is a problem, we may have to ask you to move your dogs if they are being a nuisance to others.

Tuesday - Special Attraction for SCA Nationals

Personalized rosettes will be presented to all entrants. This event will be held following the **Time to Beat** class and any course and any jump height can be selected by the handler.

DIRECTIONS TO THE TRIAL SITE

From the West /East via the OH turnpike –Exit 152 (St Rt. 10 Lorain Rd). Turn east (right) on Lorain Rd. The Soccer Sportsplex is 2 miles on your right

From the East via I-480 - Take I-480 West to Exit 2 (Lorain Rd). At end of ramp turn right and go .2 miles to the Soccer Sportsplex on right

From the North – Take I90 to I-271 South. Take 271 to I-480 West to Exit 2 (Lorain Rd). At end of ramp turn right and go .2 miles to the Soccer Sportsplex on right.

From the South – Take I-71 North to I-480 Toledo exit. Take I-480 West to Exit 2 (Lorain Rd). At end of ramp turn right and go .2 miles to the Soccer Sportsplex on right.

BEWARE - the police are there to enforce the speed limit on Lorain Rd and they do!

RV MOTORHOME PARKING – NO Hookups

North Olmsted Soccer Sportsplex Rules

- Crating space is limited. Exhibitors need to consolidate their crating area.
- Dogs are not allowed to relieve themselves on the shrubbery in front of the building or on the building.
- Use only the designated potty areas.
- Plastic/tarp must be placed under all crates.
- NO straight-legged chairs allowed on the turf.
- Food available on site – food may only be eaten in the food court.
- No outside food can be brought in. MACH cakes may be brought in only if cleared with the trial secretary. They only allow us to have one cake per day for MACH earned at this show.
- NO SMOKING inside the building.
- **Anyone not cleaning up after their dogs anywhere will be asked to leave the show grounds.**
- NO bitches in season allowed in the building.
- NO grooming allowed in the building. Please brush your dog before the trial to minimize shedding on the floors.
- Ex pens will be allowed for multiple dogs only.
- Crates and personal property may be left overnight at your own risk.
- NO Flash photography allowed.
- Reminder – to keep this awesome site we need to keep it clean inside and out.
- The AC is usually quite cool so may want to bring a sweatshirt!

Additional policies...

- Reminder that reactive dogs will be asked to move if they are causing a commotion. Don't stress your dogs by putting them in an area they cannot handle.
- Exhibitors and dogs are NOT allowed in the fenced soccer area outdoors for any reason.
- If there are any issues with the site please speak to the Trial Chair not the Soccer Sportsplex personnel.
- Please respect the ropes keeping you off the neighboring lawns at all times.
- If you want to be a vendor even for small items, you must speak to the trial chair. There is a vendor fee.
- Once the trial is over there is no set up for the next day. This is for the safety of the exhibitor's belongings. The Soccer Sportsplex staff will keep people away from the agility areas.
- Per AKC rules, pups under 4 months of age are not allowed on the grounds.
- **When sitting in the bleachers at ground level, please do not let your dog sit in the aisle; it makes it too hard for traffic to flow thru.**
